## EAST CONEMAUGH BOROUGH CAMBRIA COUNTY, PA.

ORDINANCE NO. 04-02

AN ORDINANCE OF EAST CONEMAUGH BOROUGH CAMBRIA COUNTY, PA. ESTABLISHING STOP SIGNS ON 5TH STREET AT LOCUST STREET; (LOCUST STREET AT 5TH STREET); LOCUST STREET AT 1ST STREET; AND 1ST STREET AT LOCUST STREET; MAKING LOCUST STREET A TWO-WAY TRAFFIC STREET FROM GREEVE STREET TO 1ST STREET WITH ALTERNATE SIDE OF STREET PARKING; PROVIDING FOR AN EFFECTIVE DATE AND PENALTIES FOR VIOLATIONS.

WHEREAS, the Borough of East Conemaugh has a duty to regulate the speed, volume, and direction of motor vehicle traffic on its roadways within the Borough for the safety of its residents, pedestrians, and motor vehicle traffic;

WHEREAS, the Borough of East Conemaugh has determined by reports from its residents, police, road workers, and observations by Councilmen that certain changes to the flow and direction of motor vehicle traffic on 1st Street, 5th Street, and Locust Street would be in the best interests of its residents, pedesterians, and motor vehicle traffic on those streets;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED and the same is hereby Ordained and Enacted by the Borough of

East Conemaugh, as follows:

- A. That official Stop Signs shall be erected on 5th Street at Locust Street, Locust Street at 5th Street, Locust Street at 1st Street, and 1st Street at Locust Street and requiring all motor vehicles to bring their vehicles to a complete stop in obedience to said signs; that Locust Street shall be a two-way traffic street from Greeve Street to 1st Street with alternate side of the street parking which shall be indicated by appropriate signage.
- B. That all other Borough Ordinances, or parts thereof, are hereby repealed in so far as they are inconsistent herewith.
- C. That anyone found in violation of this Ordinance shall be guilty of a summary offense and subject to a fine of not more that \$300.00 and/or ninety (90) days in jail, and any vehicle being in violation of the alternate side of the street parking restriction shall be subject to immediate towing/removal and impoundment at the owners's expense.
- D. This Ordinance shall become effective upon passage by Council.
