

**AN ORDINANCE FOR THE BOROUGH OF EAST CONEMAUGH, CAMBRIA COUNTY,  
PENNSYLVANIA PROHIBITING THE MANUFACTURE, DISTRIBUTION, AND SALE OF  
ELECTRICITY WITH THE BOUNDARIES OF THE BOROUGH OF EAST CONEMAUGH,  
PENNSYLVANIA**

**ORDINANCE NO. 23-04**

**WHEREAS**, the Borough of East Conemaugh, Cambria County, Pennsylvania (hereinafter referred to as "Borough"), is a municipality organized and existing pursuant to the laws of the Commonwealth of Pennsylvania, more specifically the Pennsylvania Borough Code (8 Pa. C.S.A. § 101 et seq.) (hereinafter referred to as the "Borough Code"); and

**WHEREAS**, pursuant to 8 Pa. C.S.A. § 1202(62) of the Borough Code the Borough is empowered "to manufacture, purchase or otherwise supply electricity pursuant to Chapter 24A of the Borough Code relating to manufacture and supply of electricity; and

**WHEREAS**, the Borough distributes and sales electricity to electrical users within the boundaries of the Borough; and

**WHEREAS**, 8 Pa. C.S.A. § 24A02(d) prohibits any person, partnership or corporation to introduce electric current for light, heat or power purposes, into the limits of any borough without the consent of the Borough; and

**WHEREAS**, 8 Pa. C.S.A. § 24A02(d) does not apply to any person, partnership or corporation manufacturing electricity exclusively for its own use; and

**NOW THEREFORE**, the Borough of East Conemaugh hereby ordains the following:

**I. AUTHORITY**

- A. 8 Pa. C.S.A. § 1202(62) empowers the Borough "to manufacture, purchase or otherwise supply electricity pursuant to Chapter 24A of the Borough Code.
- B. 8 Pa. C.S.A. § 24A02(a) permits a borough to manufacture or purchase electricity for the use of its inhabitants...."
- C. 8 Pa. C.S.A. § 24A02(d) prohibits any person, partnership or corporation to introduce electric current for light, heat or power purposes, into the limits of any borough without the consent of the Borough.

**II. SCOPE**

- A. To prohibit any person, partnership or corporation to introduce electric current for light, heat or power purposes, into the limits of the Borough without the consent of the Borough.
- B. This ordinance shall not apply to any person, partnership or corporation manufacturing electricity exclusively for its own use.

**III. PROHIBITION OF INTRODUCING OR SELLING ELECTRICITY WITHIN THE BOUNDARIES OF THE BOROUGH**

- A. No person, partnership or corporation shall introduce electric current for light, heat or power purposes, into the limits of the Borough without the consent of the Borough.

- B. No person, partnership or corporation shall sell electric current for light, heat or power purposes, within the limits of the Borough without the consent of the Borough.

**IV. EXCEPTION TO INTRODUCING ELECTRICITY WITHIN THE BOUNDARIES OF THE BOROUGH**

- A. This Ordinance shall not prohibit or apply to any person, partnership or corporation located within the boundaries of the Borough to manufacture electric exclusively for its own use.

**V. EFFECTIVE**


- A. This Ordinance shall become effective immediately.


